ABSTRACT

This dissertation is focused on Emergency Provisions of the Constitution of Bangladesh. This dissertation aims to show how the rights of the citizens are violated by police and other law enforcement agencies in the emergency period. The definition of emergency, how and when emergency can be declared, its background and negative effects have been analyzed here.
